She has been setting-up and is now supporting the implementation of the European Innovation Partnership "Agricultural Productivity and Sustainability" (EIP-AGRI), with responsibilities for the rural development programmes and strengthening linkages between research and rural development policies. As member of the DG AGRI Taskforce "Research and Innovation" she was instrumental in shaping DG AGRI's research and innovation approach in Horizon 2020 Work Programmes since 2012, and developed the new research project formats "multi-actor approach" and "thematic networks", for which she is still responsible. Meanwhile, one of her core tasks has become the development and implementation of the policy on Agricultural Knowledge and

Before working at the Commission Inge Van Oost was coordinator of the demonstration projects at the Directorate-General for Agriculture and Horticulture of the Flemish Region. There she drafted rural development measures and designed the farm advisory system. In the meantime, she was evaluator of many agricultural research projects and member of diverse selection committees. In the former federal Belgian Administration for Agriculture she served the Secretariat-General as coordinator of the Horticultural Chain, dealing with chain management, food quality, traceability and safety, sustainability of production methods, communication with consumers and much more.

Before joining the administration, she worked as a farm advisor, and after a while as the coordinator of the advisory team. Based in an applied research institute, the team did not only advise farmers, but also brokered and implemented multi-actor experiments and on-farm demonstration projects.

Janusz Wojciechowski

EU Commissioner for Agriculture and Rural Development

Member of the European Commission since 1 December 2019, responsible for Agriculture. Lawyer; Attorney.

Commissioner Wojciechowski grew up on a farm in Rawa Mazowiecka, a rural community in the Łódzkie region in central Poland. He holds a Master's degree in law, having graduated from the University of Łódź Department of Law and Administration. His professional career as a judge spanned different levels up to membership of the Supreme Court of Poland. From 1995 to 2001 he held the important post of President of the Polish Supreme Audit Office.

From 2001 to 2004, he represented the Łódzkie constituency as a Member and also Vice-Marshal of the Parliament of the Republic of Poland – the Sejm. From June 2004 until May 2016, he served three terms as a Member of the European Parliament. He sat as a Member of the European Parliament's Intergroup on the Welfare and Conservation of Animals from his first term and from 2014 to 2016 he was President of the Intergroup.

From May 2016 to November 2019, he was a Member of the European Court of Auditors.

Commissioner Wojciechowski has been the author and co-author of five comments on the Polish Penal Code, as well as the author of more than 100 articles and publications on criminal law in various Polish legal magazines. He also writes on socio-legal issues.





Pieter Spanoghe

Ghent University, BE

Pieter Spanoghe is Professor and has been Head of the Department of Crop Protection Chemistry at Ghent University since 2012. The Laboratory, as part of the department of Plants and Crops, is highly skilled in the monitoring of pesticide residues in crops and foodstuff and environmental samples (soil, water and air), formulation work of active ingredients, and the study of possible side effects of pesticide usage and human and environmental risk assessment and risk management.

Prof. Pieter Spanoghe teaches on all aspects of Crop Protection Chemicals: major topics are the history of pesticides use, different types of pesticides, mode of action of pesticides: insecticides, fungicides and herbicides, analytical aspects of pesticides, application techniques, environmental fate and behavior, human exposure during and after application, food safety, mitigation strategies and risk assessment systems (risk indicators).

In May 2019 Pieter Spanoghe was the chairman of the 14th international IUPAC symposium on pesticides. All aspects of pesticides were addressed during this global conference.

Since January 1st, 2019 he coordinates a Horizon2020 Thematic Network project Euraknos: Connecting Thematic Networks as Knowledge Reservoirs: towards a European Agricultural Knowledge Innovation Open Source System. On January 1st, 2020 he started a second Horizon 2020 multi-actor project Eureka: European Knowledge Repository For Best Agricultural practices. Both projects aim to construct a sustainable EU wide electronic data platform collecting and centralizing data from all EU multi-actor Horizon2020 agricultural projects. The platform or 'farmbook' will store end-user material to enhance sustainability in agriculture.

Gintare Kucinskiene - Head of Innovation Support Service - started her carrier in the agricultural sector in 1998 and has extensive experience.
